No. LJ(A) 77/2000/Pt/158 – For the purpose of the Rules for the Administration of Justice and Police in the Garo Hills District, 1937 read with paragraph 2 of the Sixth Schedule of the Constitution, the Governor of Meghalaya, with the approval of the Hon'ble High Court of Meghalaya, is pleased to appoint Shri M. Skhemlon, Chief Judicial Magistrate, as the Assistant to Deputy Commissioner, East Garo Hills District and further under rule 16 of the aforesaid rules, invest him with the powers of the Judicial Magistrate of the First Class as per spirit of the Code of Criminal Procedure, 1973 within the East Garo Hills District with effect from the date of joining.
