THE MEGHALAYA APPROPRIATION (NO. II) ACT, 2014

An

Act

to authorize payment and appropriation of certain sums from and out of the Consolidated Fund of Meghalaya for the services of Financial Year ending on the thirty first day of March, 2015.

Be it enacted by the Legislature of the State of Meghalaya in the Sixty-fifth Year of the Republic of India as follows:-

Short title and
Commencement

1. (i) This Act may be called the Meghalaya Appropriation (No. II) Act, 2014.

(ii) It shall come into force on the first day of April, 2014

Withdrawal of
₹ 11933,67,05,600
from and out of the
Consolidated Fund of
Meghalaya for the financial
year 2014-2015.

2. From and out of the Consolidated fund of Meghalaya there may be paid and applied sums not exceeding those specified in Column (3) of the Schedule amounting in the aggregate inclusive of sums specified in column (3) of the schedule to the Meghalaya Appropriation (Vote-on-Account) Act, 2014 to the sum of ₹ 11933,67,05,600 (Rupees eleven thousand nine hundred thirty three crore, sixty seven lakhs, five thousand, six hundred) only towards defraying the several charges which will come in course of payment during the financial year ending on the thirty first day of March, 2015 in respect of the services specified in Column (2) of the Schedule.

Appropriation

3. The sums authorized to be withdrawn from and out of the Consolidated Fund of Meghalaya by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
