No. LJ(A) 77/2000/Pt.I/8 –For the purpose of the Rules for the Administration of Justice and Police in the Garo Hills District, 1937 read with paragraph 5 of the Sixth Schedule of the Constitution, the Governor of Meghalaya, with the approval of the Hon'ble High Court of Meghalaya, is pleased to appoint Shri D.S. Marbaniang, Chief Judicial Magistrate, Tura as the Assistant to Deputy Commissioner, West Garo Hills District and further under rule 16 of the aforesaid rules, invest him with the powers of the Judicial Magistrate of the First Class as defined in the Code of Criminal Procedure, 1973 within the West Garo Hills District including Dadengre (Civil) Sub-Division with immediate effect.
